

Layer 1: Creating

 Develop a next-generation healthcare management system (tentative name) to analyze the latest evidence and clinical data with big data using AI to support optimum medical treatments on site.


Layer2: Connecting

- Integrate basic health care data around the individual, from that individual's healthy stages to stages of disease and long-term care.
- Develop PeOPLe (tentative name), shared by health care professionals where all patients and the public can participate so that they as individuals can use it for their own health management.

Layer3: Expanding

- Various actors in industry, government, and academia have access to the data and utilize this medical and long-term care health care data in the form of big data.
- Development of a data utilization platform (tentative name) that can collect, process (anonymize, etc.), and provide health care data by objective according to various needs from industry, government, and academia from PeOPLe (tentative name) and databases by objective.
